

SCHEME

- In this project 57 double occupancy rooms and 90 Single Occupancy rooms will be allotted to the eligible senior citizens on "Live and License" basis.
- All such rooms will be allotted through Lottery.
- Single Occupancy rooms are meant for Single occupants and double occupancy rooms are meant for double occupants.
 However, any individual can opt for double occupant room if SD is paid accordingly.
- No extra person will be allowed to stay with the Licensee excepting extreme urgency on medical grounds or any other ground which the authority may think fit to allow extra person with the written permission of the authority and on payment of fees. But in any case more than three days will not be allowed.
- Right of Rooms is not transferrable. Allotment of rooms will be cancelled if possession is not taken and Licensee does not stay here for continuous three months without prior sanction from the authority of WBHIDCO.
- Security Deposit will have to be paid by the Licensee, if successful in the lottery, as per rate as mentioned at Table-1 in this brochure.
- In addition to payment of Security Deposit, Licensee will have to pay Monthly Fixed Charges @ ₹16,000/- (Rupees sixteen thousand only) excluding applicable taxes viz. GST etc. per person for food, beverage and other charges, as applicable. Monthly charges will have to be paid by the Licensee irrespective of his/her absence.
- Monthly Charges will be increased @ 5% per annum on the payment made previous year from the date of commencement of the project.
- 75% of Security Deposit is refundable to the legal heirs of the Licensee in the event of death of the Licensee or to the Licensee himself/herself in case of surrender of allotment/allotted room.
 No interest however would be payble.

- 90 Single bedded and 57 Double-bedded residential units with all supporting services and amenities for comfortable and peaceful living of senior citizens.
- Physiotherapy Center with Hydrotherapy, yoga and gym facilities subject to viability, on payment.
- Centralized cooking and housekeeping services
- Regular medical checkup facilities.
- Utility and Medicine Shop
- Monitoring of general health and preventive health check-ups by the in-house medical professionals, maintenance of health records of all residents, emergency evacuation to partner hospital.

SCHEDULE OF APPLICATION

Application brochure form will be available from the above designated branches of Axis Bank from 25/09/2017 to 31/03/2018 during normal banking hours.

Filled in application forms will be received at the above noted branches of Axis Bank from 10/10/2017 to 31/05/2018 during normal banking hours.

GENERAL TERMS AND CONDITIONS (GTC)

- All rooms in the scheme will be allotted on Live on License basis through draw of lottery in a transparent manner.
- Security Deposit (SD) shall be paid as per Table-1 during the construction phase. Applicant can also pay entire SD at one time.
- There are two category of rooms i.e. Category A: Double occupancy and Category- B: Single Occupancy. Rooms at 9th floor and 10th floor will be treated as Premium floors and additional SD of ₹ 5 lakh will be charged over and above the basic SD and applicant has to pay it with the first installment of SD.
- There may be some Empanelled Service Providers (ESP) who will provide various services on demand and on payment separately to ESP.
- Payment towards SD will have to be made to HIDCO.
- The design and specifications as mentioned in the brochure are indicative and may vary according to the situations and as implemented.
- Expected date of completion of the project is within December 2018.
- Applicant(s) is/are required to submit documents (as mentioned in pg 24) at the time of submission of application.
 Only successful applicants after the draw of lottery will have to submit self attested copy of other documents as mentioned in this Brochure, at the time of interview/health check-up.
- All 147 rooms will be allotted through draw of lottery if number of applicants is more than the number of rooms in each category.
- One person per applicant will be invited to remain present at the time of lottery at the appointed date/time and venue showing original ACKNOWLEDGEMENT SLIP and any photo identity card.
- There will be lottery if the number of application is more than the number of available rooms in each category under the scheme.
- If number of applicants are less than number of rooms available for each category, rooms will be allotted straightway upon verification of documents. Rooms numbers will be decided through draw of lots.

- Immediately after draw of lot, letter of intimation will be issued to the successful applicants requesting to submit documents
 and for appearing for a medical check up and interview. The decision of the doctor and the interview board will be final. The
 prime focus would be to screen out persons unfit for independent living as envisaged in Snehodiya. Consequent vacancies
 may be filled up from wait listed panel till 6 months.
- Submitted application within due date will be treated as valid only if application money is deposited and credited to the account of WBHIDCO Ltd.
- In case full information is not given as per Application Form or the information furnished does not support the application, the application form will be liable to be rejected automatically.
- Mere submission of application does not accrue right for the allotment of room.
- Application money will be refunded to the unsuccessful applicants through electronic transfer to their bank account directly as mentioned by the applicant in the application form. No interest will be paid to the unsuccessful applicants for application money so deposited by them.
- For refund of application money, applicants will mention Bank Name, Branch Name, Account No., IFS code, SWIFT code, BIC code, as may be applicable, in the Application Form. This corporation will not be held responsible for non-refund of application money in time due to wrong/insufficient information given by the applicant.
- The licensee will have to pay Monthly charges @ ₹16,000/- plus applicable tax for food, beverages and other services.
- Monthly charges is payable within 7th day of every successive month.
- The monthly Charges will be increased @ 5% per annum on the payment made previous year from the date of commencement of the project.
- The authority may revise Monthly charge even in the interim period for reasons to be recorded and divulged.
- In the event of failure to deposit monthly charges for more than three consecutive months whatever be the reasons, the allotment is liable to be cancelled.
- All allottees shall take over the possession of the rooms within 15 days (Fifteen) from the date of issue of intimation letter. If possession is not taken and if the Licensee fails to stay at SNEHODIYA, the allotment is liable to be cancelled.
- The Licensee has to pay Fixed Monthly charges for food and beverages and other charges irrespective of his/her absence.
- All receipts of payment should be preserved carefully and be produced whenever required. The last receipt must be produced while paying each subsequent installment.
- Applicant shall fill up CHECK LIST as contained in the application form.
- AADHAR is mandatory for all applicants.



DOCUMENTS TO BE FURNISHED

The applicants are required to submit the following documents along with application form at the designated branches of Axis Bank:

- a. Employment cum Income Certificate/Pension certificate/Salary certificate.
- b. Self attested copy of PAN card.
- c. Self attested copy of Voter ID/Service Identity/AADHAAR as proof of identity.
- d. Self attested copy of Passport/Electric Bill/Telephone Bill/Bank Pass book showing address/ Driving License (DL), as a proof of residence.
- e. Copy of latest IT Return (Assessment Year 2017-18).
- f. One photocopy of DD/PO drawn towards application money and one self attested photocopy of acknowledge slip of payment of application money.
- g. One cancelled CTS cheque of the bank account of the applicant.
- h. Passport size recent photograph for both 1st applicant and joint applicant, if any.

JOINT APPLICATION

Joint application for double occupancy rooms in the same room will be permitted.

PAYMENT STRUCTURE

- Each applicant has to pay ₹ 25.00 lakhs exclusive of applicable taxes, if any, as Security Deposit (SD) for Single occupancy room, ₹45.00 lakhs for double occupancy room upto 8th Floor and Rs.50.00 lakhs for double occupancy room at 9th and 10th Floor (Premium Floors).
- SD should be paid either in two installments or in full at a time. The SD is refundable to the tune of 75% within three months of discontinuation of stay to the nominee/legal heir/resident himself/herself. Rest 25 % will be retained by HIDCO. No interest would be payable.
- Applicants can avail 10% discount on booking of single occupancy in twin sharing rooms. This facility is available during the construction phase only.
- Fixed Monthly charges will have to be paid by 7th of every succeeding month. In the event of failure to pay Monthly charges for consecutive three months, allotment will be liable to be cancelled.
- Monthly charges may, however, vary for use of Individual laundry, Medical & Non-medical services based on physical condition of the occupant which are not included in the list of common services.
- Application money of ₹1,00,000.00 (Rupees one lakh) only, would have to be deposited through Demand Draft / Pay Order drawn in favour of WBHIDCO Ltd. payable at Kolkata. The 1st and 2nd installment amount of the security deposit shall also have to be deposited through DD/PO as per payment schedule mentioned in Table 1.

PAYMENT OF INTEREST

WBHIDCO Ltd. or the designated bank, shall not pay any interest on Security Deposit on account of any kind of refund / withdrawal / cancellation cases or any other money paid by the applicant.



If installments as scheduled above (Table 1) are not paid in time, the applicant shall pay delay payment charge (DPC) @12.5% p.a on the installment(s) amount due. If a particular payment is not paid in time, the Chairman of WBHIDCO Ltd. may consider extending the date of payment by maximum of 30 days for clearing the default amount with DPC, failing which the allotment will be cancelled.

WITHDRAWAL AND FORFEITURE CONDITIONS

- If after application, the applicant withdraws himself / herself from the scheme before the draw of lots, if any, 10% of the application money will be deducted by WBHIDCO Ltd. as service charge.
- In case of withdrawal by an applicant who is successful in the selection of allottees, either before or after issue of allotment letter, 25% of the application money will be deducted by WBHIDCO Ltd. as service charge.
- Any subsequent withdrawal from the scheme by the applicant, i.e., after the first or second installments paid, the full amount of application money plus 10% of the installment(s) paid will be forfeited to WBHIDCO Ltd. as service charge.





CANCELLATION AND FORFEITURE CONDITIONS

- The allotment will be cancelled if any discrepancy is found between the documents submitted and the information given in the application form and in such case entire money deposited will be forfeited.
- In case any statement / affidavit / document supporting an application is proved to be false or found fabricated at any stage, the entire sum paid by the applicant will be forfeited to WBHIDCO Ltd. and will also involve an instant cancellation of the application concerned.
- The allotment may be cancelled if the payment of SD is not made as per payment schedule even after maximum extension of time with delayed payment charge.
- In the event of death of the applicant before draw of lots, application money will be refunded without any deduction or any interest to the heirs of the applicant.
- Cancellation of application, if any, by WBHIDCO Ltd. for valid reasons before the lottery may not attract any deduction while making refund.
- In the event of failure to make payment of Monthly Charges in time the allotment may be cancelled.

OTHER TERMS & CONDITIONS

- Agreement will be executed on payment of full SD including delayed payment charge, if any, and documentation charge.

MODE OF DISPOSAL

WBHIDCO Ltd. will fill up all seats in SNEHODIYA by open advertisement in various newspapers (both vernacular and English) and allotments will be made by draw of lots, if number of applicants are more than admissible seats of accommodation, in a transparent manner and in presence of applicants willing to remain present on the date of draw of lots. All selected applicants will have to submit health check up report and appear for an interview and may be rejected on reasons to be recorded in writing .There will be no Chairman's Quota.

TRANSFER OF SEAT

Floor wise allotment of seats in rooms will be decided by HIDCO and binding upon all. However, HIDCO may consider any prayer for change of seat from one room to another or from one floor to another on merit provided there exists vacancy. HIDCO may also allow mutual shifting of seats among occupants.

SITE INSPECTION

All intending applicants are advised to visit the site before applying.

Applicants may also visit the helpdesk / our site office located at Senior's Park, New Town and may get details of the scheme.

DISPUTE REDRESSAL

If any dispute/differences arises in this matter, the decision of the authority of WBHIDCO shall be final and binding upon all.
